1. Apologies for Absence

Item 9 (February 2021) – Acting Headteachers Report

Mrs Stobbart has contacted the Transport Department at County who don't seem interested in helping out schools but would be more inclined to respond to requests for help from individual families. However, the Council do operate a spare seat scheme whereby those families out of catchment can apply for a seat on school buses should there be any spare at a cost of £174 for Autumn Term, £164 for Spring Tern and £104 for Summer Term.

In addition to this Mrs Stobbart has also enquired with current providers as to whether they would be able to offer this provision as a private arrangement; this would be at a cost of £20 per day. Although none of the families concerned have pursued this further yet Mrs Stobbart asked the Governors if they would consider financial help towards this in the future; all agreed this would be something the Governors would consider but on an individual, annual basis.

There is a bus comes up from Brampton area to collect children to take to school and there are spare seats on this, it was suggested that maybe we could ask them to display our school logo in the window as advertisement as it may encourage others.

5. Governing Body Membership

Mrs Patrick-Jones has been nominated to County to fill the outstanding vacancy for Local Authority Governor.

6. Finance & Leadership Committee Report

There is a meeting of the Finance & Leadership Committee scheduled for Tuesday 11th May 2021 in order to complete and submit the SFVS and discuss budget setting.

However, Mrs Stobbart and Mrs Rooney have met with Kim Brown and confirmed a year end carry forward of £39,864 for 2020/2021 and £66,194 for 2021/2022; requiring school to spend approx. £50,000 before the end of March 2022. This is above everything that has been budgeted for.

In addition to this there is also £25,231 of sports funding still to spend but school have plans for this in the outdoor area by improving facilities, daily mile track etc. and are also looking at erecting an outdoor classroom possibly to aid with the EYFS /nursery plans.

It was noted that of the formula capital figure of £16,391, £3727 of this is to draw down before March 2020 also.

Balance carry forward for the year at present is approx. £39,864.

Governors Account Balance as at 1st May 2021 is £24,820.72.

7. Teaching & Learning Committee Report

There has been no meeting of the Teaching & Learning Committee prior to this meeting but it was requested that the committee meet prior to the next FGB meeting with a focus on all aspects of reading throughout school.

8. Health, Safety, Buildings & Premises Committee Report

There has been no meeting of the Health, Safety, Buildings & Premises Committee prior to this meeting but Mr Lamb has conducted the Health & Safety Audit and this has been issued to all Governors for their information. Actions have been set following on from this and school are beginning to work on them.

9. Acting Headteachers Report

Mrs Stobbart provided a written report prior to the meeting.

In addition to this it was reported that the recent parents evenings were very positive with the majority of parents in attendance and those who couldn't have been scheduled in for the near future, the school 100 club has been launched with great support from the community and 1 request for absence during term has been received.

Mrs Stobbart also reported that the mid-year performance reviews are under way but not completed yet and Mrs Alston and Mrs Lamb have a date to complete the Acting Headteachers mid-year review.

Mention was given to pupil questionnaire survey that school currently undertook with the children; all children are happy and glad to be back at school with their friends.

10. Headship September 2021

Mrs Alston once again went over the structure for the Headship at school from September 2021 for clarification and reported that Mrs Lyons is organising the issue of the new contracts for Mrs Stobbart and Mrs Rooney.

Mrs Stobbart and Mrs Rooney are currently discussing Job Descriptions and split of responsibilities and this will then be brought to the FGB for ratification.

14. Arrangement with Irthington School

Mrs Alston confirmed that she has written to the Chair of Governors at Irthington School thanking them for the support received from Mrs Harrison via the partnership agreement that has been in place between our schools since September 2019.

15. School Meals – New Arrangement Update

Mrs Stobbart reported to Governors that the new school meal arrangement with Lanercost School through Orian began on 19th April 2021 and despite a few teething issues at the start is beginning to work. School will continue to monitor the arrangements as they are not prepared to compromise quality for quantity.

16. GB Health Check & Skills Audit

Governors were provided with the results of the recent GB Health Check and Skills Audit that had been undertaken and these were briefly discussed; Governors felt that they would like to discuss the findings further in a face to face meeting, date to be decided.

Some staff Governors felt that they were comfortable answering the questions as staff but not so much so as a Governor.

It was agreed that we currently have a diverse skill set among the Governing Body with no area lacking at present.

17. Governor Monitoring

Health & Safety Audit - This has been completed; see Item 8 of this Agenda. In addition to this it was noted that there was a recommendation to provide Mrs Stobbart with paid extra time to learn and understand procedures throughout school should she need it; this was agreed by all Governors.

Guided Reading Zoom Sessions – Mrs Irving has been unable to complete this monitoring as of yet but this will now be undertaken by the Teaching & Learning Committee.

Mr Lamb suggested that school look into possibly working with the 'Mini Police' scheme provided by Cumbria Constabulary that is aimed at 9-11 year olds. Mrs Patrick-Jones has some involvement with Cumbria Constabulary and will look into the possibility of what links may be available to school.
